


## 2022 Report of the Technical Committee on Data Exchange

### AGENDA ITEMS 1 & 2 Welcome and Introductions

#### **Status of Ciguatera Fish Poisoning project, and data handling**

Dr. Daisuke Ambe, TCODE member representing the PICES-MAFF Ciguatera Fish Poisoning (CFP) project, presented an update. Changes in data handling during the course of the project came to light and discussions on how to proceed ensued. TCODE accepted the suggestion to allow the government of Indonesia to maintain ownership of the data from the project after considering their willingness to pay for the data gathering and interview process. It was suggested that the Indonesian government be asked to consider long-term archival and storage of the data after the project is finished.

#### **Update on IOC/IODE**

Dr. Yutaka Michida, *ex-officio* member representing IODE, provided an update on the contribution to the UN Decade of the Ocean, past and upcoming meetings and workshops, and potential areas for increased collaboration between PICES and IOC/IODE, including active participation of PICES in IODE sessions, and the 2023 Ocean Data Conference II as a partner international organization.
