AP-CREAMS Report (SungHyun Nam)

The current term ends October 2024 and needs an extension. There is currently no member from Canada and only one from USA. There is one member from ECOP and would like more. There were three meetings this year (two in-person, one online), two workshops (CREAMS 30th anniversary, PICES), and one scientific session. AP-CREAMS is actively cooperating with other organizations (e.g., IMBeR, UNDOS). There are several action items following up from the 30th anniversary meeting that are related to PICES: topic session in PICES 2025; extend the term in PICES to 2029; expand geographic area to include more of NW Pacific (most of coastal NW Pacific to Bering Sea). Accordingly, the ToR and Action Plan will need to be changed and these requests were endorsed by POC.

S-CC Report (Alexander Kozyr)

The following were identified as scientific achievements: started re-submission of metadata of coastal/domestic OA/deoxygenation monitoring to GOA-ON; promoted PICES 2024 session; and attended global ONCE online forum.

The following is a list of comments from the discussion:

Fangli–The committee tried their best, but know the final report isn't perfect and hoping to get some feedback from PICES members.

Steven–great report with a lot of great ideas; one of key decision points is the recommendation that PICES pivots to solution-based science that is responsive to member countries and specifics come out of that philosophy–will make organization more like ICES. Steven is very supportive of this idea; some aspects very relevant to POC (predictions, forecasts, etc.) but need to be careful as an organization to not overcommit.

Jerome-thinks it's a very big ask to host/serve data, especially climate projections. Will PICES then be a gateway to the data? Fangli says that change needs to happen slowly, but data are needed.

Jim–agrees with Jerome that this is potentially a very large undertaking. It is acknowledged in the report that this is a substantial new undertaking that will require substantial new resources from member countries.

Alex-data should be protected against natural disasters (e.g., Hurricane Helene cut off power to cooling system for server).

Request that everyone answer poll that was sent by the PICES Secretariat.

Agenda Item 6

More Discussion on the Proposal for a New WG (Nianzhi Jiao or Yanli Lei)

Yui asked how this working group will work with other groups who are doing similar studies; will methods be comparable? The answer was that the WG will focus on biological CDR. Tsuneo asked if they are planning to create a new standard that is different than ISO and the answer was that it is possible. Tsuneo is concerned that there may not be enough time in WG to publish a new ISO standard. The group believes that they can create this faster.

Agenda Item 7

Argo Report (Yui Takeshita)

A question about quality control for BGC data was asked regarding real time data and the answer was there is a delay mode control twice per year and then applied to real time data. There is resource limitation in the data assembly centre, which slows down the process. Another question was asked about making code available for radial interpolation and it will be investigated. There is an appetite for working groups that focus on Argo data assimilation in models. Jim explained that, in Canada, both short-term and seasonal predictions (up to 1 year) are made operationally; in both of these systems, Argo is the most important source of initialization data.

SOLAS Report (Bill Miller and/or Christa Marandino)

Fangli suggested that PICES will pay more attention to prediction and will have more space for cooperation with SOLAS. Perhaps a joint working group or session between SOLAS and POC would be useful. Fangli asked whether air-sea interaction, surface waves are important and a possible avenue of collaboration? The answer was that SOLAS is for leveraging and doesn't want to be directly involved with industrial solutions—mCDR is crowded already and SOLAS has been doing this since 2004 so has a lot to offer in this space.
